We'll explore how we can create a ripple effect through enhanced collaboration across projects, countries, and sectors. Through unconventional approaches and programming, stepping out-of-the-box, we unlock break throughs, which will lead to accelerated results for environmental security in the Mediterranean Basin.

Background

In the framework of the Global Environment Facility (GEF) funded Mediterranean Sea Programme (MedProgramme) "Enhancing Environmental Security" (GEF ID 9607), the United Nations Environment Programme (UNEP) / Mediterranean Action Plan (MAP) is organizing the Third Annual Stocktaking Meeting of the GEF-UNEP Mediterranean Sea Programme (MedProgramme), convened in cooperation with the implementing agencies UNEP and the European Bank for Reconstruction and Development (EBRD), and the executing partners of the MedProgramme's eight (plus FishEBM) Child Projects. The meeting will be held in Istanbul, Türkiye, from 8 to 10 April 2025.

Day 1: Integration is an art

We kick-off this year's ASM by exploring the meeting theme, integration, in an inspirational manner. What does it take to be greater than the sum of its parts? After setting the stage, we'll continue by revising the separate pieces of the puzzle, starting with the glue of the MedProgramme, Child Project 4.1 – an update on Gender, Communications and Knowledge Management activities. Subsequently, the implementation progress and way forward of the different Child Projects will be presented, preparing for the sessions on day 2.

Day 2: Putting the pieces together

This day will be fully dedicated to exploring key outcomes and progress, challenges and solutions of the different Child Projects. Through different styles of round table discussions, guided by experts and 'the arts', we deep dive into technical and social aspects of project implementation, challenges, synergies and integration of results.

Day 3: Closing the circle

To close the circle, the last day of this year's ASM finishes like it started, by exploring the concept of integration. We address cross-cutting issues spanning across the MedProgramme, which are at the same time relevant to ongoing conversations in the environmental space. Finally, we consolidate our findings, identify further potential for synergies, replication and integration, and outline the next steps for enhanced visibility, advocacy and joint delivery of a more interconnected MedProgramme.

Note: This is not just a meeting; it's an invitation to **working sessions designed to co-create**. Your insights, expertise, and collaboration are what make the MedProgramme a thriving model for environmental cooperation.
